STEP-BY-STEP INSTALLATION


- **Step 1.** Carefully read the End User License Agreement contained on the CD or the accompanying packaging before using and/or installing this product.
- Step 2. If you plan on installing mass spectrometry software install the software now, first.
- **Step 3.** Installation.htm is included on the disc to simplify installation. Manual installation instructions are available elsewhere in this manual. Please note that the web page contains embedded links or ActiveX that may create warnings such as the following (1) and (2):

Step 4. Password and Install

Choose a format to install. Many users prefer to use native manufacturer format and MS Search format. You may choose to install one manufacturer format as well as the MS Search format. When you choose to install, you may get a series of warnings about publisher certificates (4). Choosing to run the installer will bring you to a password screen (5). Your password appears on the back of the CD packaging. It is case sensitive. Enter the password to begin the installation and press "OK" (6). If the password is incorrect, the "OK" button will not activate. If you have trouble at this stage, consult "Help" on the installation screen in your browser.

The InstallShield wizard will display the following screens, indicating that it is checking the computer for installation (checking available disk space, installer version, etc.). Once it is ready for installation, press "NEXT" to begin the installation, at which point it will begin uncompressing the library. The library is quite large, so this may take a considerable amount of time on some older systems:

Step 5. Welcome Screen, End User License Agreement

Once the installation is decompressed, a screen with "Welcome to the Installshield Wizard . . ." Press "NEXT" to continue (7). The next screen contains the End User License Agreement (10). Read the agreement carefully and select the radio button labeled "I accept the terms in the license agreement" to proceed to install the library. Press "NEXT" to proceed to the next step.






Step 6. User Information

Entering customer Information is recommended for your records and support (9). This information is <u>not</u> collected by Wiley.

Step 7. Directory Confirmation

Each format installs in a directory as outlined earlier in this manual. For your installation to be successful, it must install in the directory specified in your software's user manual. The installation allows you to manually change the target directory yourself by pressing "Change" (10). If you are satisfied with the target directory, press "NEXT" to proceed with the installation.

Step 8. Confirmation Screen (11)

Before starting the installation, the installer provides a summary of the destination folder and user information. Review this to ensure that it is correct. Press "BACK" to correct the user information or target directory (Steps 5 through 7).

If it is acceptable, choose to install it for "Anyone who uses this computer (all users)". The installation screen will show you the progress of the installation. Press "CANCEL" at any time to cancel the installation.

Step 9. Finish, Connect Library


Once the installation is complete, press "Finish" to complete the installation. Be sure to consult your mass spectrometry software's instructions for connecting to new libraries – some are automatic, but some require manual connection within the software.


Repairing or Uninstalling

BASIC FUNCTIONS


The enclosed library can be used as the primary search library or can be searched along with other libraries. We recommend, for mission-critical tasks, that users consult both a general library such as Wiley Registry 9e/NIST 2011 Mass Spectral Library and a specialized library such as FAMEs.

SEARCH TIPS

When using parametric searching, many text search programs provide better results when names are begun and ended with wild cards (e.g., "*"). However, in NIST MSSearch, this approach will not work.

The additional retention times are captured in the library in the comments field. To display the different measures times, go to "View"/"Comment fields Options"/ which will display the "Display comments field options" dialog. Indicate WileyID, RI1, RI2, RI3, and RI4 as the desired fields. This will then display them in the MS Search. MS Search will display literature retention times, as well.

CAS RNS

Some mass spectrometry software programs rely on a field labeled "CAS-RN" to link spectral records with their corresponding structure record. As many of the compounds found within the Wiley Registry, NIST/EPA/NIH, and other mass spectral libraries are not in the CAS Registry or do not have an assigned CAS-RN, this engineering decision would result in those spectra not being linked to their unique structure. To solve this problem, Wiley has created unique identifiers for the sole purpose of linking the spectrum and its structure using this field. To differentiate these numbers from actual CAS-RNs, each number is prefixed with the number 999.

Please note that IDs prefixed with the number 999 do not in any way represent CAS Registry Numbers, nor are they used for anything other than referring to the structure record in the separate structure database as a workaround to accommodate engineering decisions made by other software publishers.
